If swallowed	Rinse mouth. Do NOT induce vomiting. Obtain emergency medical attention.

Foam. Dry powder. Carbon dioxide. Water spray. Sand.

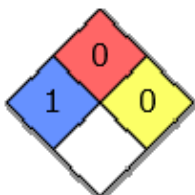
